



2024-25 FINANCIAL AID DEADLINES

In order to receive your financial aid offer prior to the beginning of your first term, please have all of your required documents complete and turned in by the following deadlines. If you meet the deadline **and are eligible for financial aid**, an offer will be sent before the start of classes. ^ If you do not meet the priority deadline, you can still enroll for that quarter. You will be expected to pay your tuition, fees, and cover the cost of books and materials while your financial aid is processed. We recommend looking into other funding sources for which you may qualify.

^In the case that we are not able to complete your packaging prior to the beginning of the term, the Financial Aid Office has the authority to place a hold on your account that allows you to attend classes without being dropped for non-payment. Holds are placed on a case-by-case basis at the discretion of the Financial Aid Office.
